## Your Association report

REGIONAL TRUSTEE
Joyce Hawley, R.N., E.T.

The Mideast Region directed me to introduce this resolution to the Board of Directors of the I.A.E.T. as a main motion.

"The Mideast Region request the I.A.E.T. act on the issue of adequate labeling of product ingredients."

That as a region we have a concern regarding poor and inadequate labeling, of absorption dressings. This is because of transcutaneous absorption. We are recommending the use of the dressing for patients, to the physician.

We as practioners may be held liable for unlabeled side effects. The Mideast Region asks the Board to take action, working either through a research committee or issue a statement for standards of practice.

The feelings of the Mideast Region are that as E.T. nurses we should use only products with adequate labeling and that product labels list expectations and limitations of the product.

Mashington Sheraton in Washington D.C.
The hotel is very nice-not sure where it is located in relation to historical sites but do know the metro is only a block away. I did notice a strip of restaurants near the hotel. It is always nice to have a choice since hotel food tends to be very expensive.

At the board meeting, I addressed your concerns. Some items were addressed directly with National office prior to the meeting. I do believe our concerns on legislation and lobbying will be addressed in Washington at Conference. Sounds like many of the sessions are geared to these

to these topics. I presented the motion on "inadequate labeling of ingredients." This generated much action. There was a statement of concern read by Pat Hottenstein for the Northeast region. There have been seven letters to the editor of the JET, T.C. Kynes says this topic has generated more concern than any previous article (JET Vol. 12 No. 6, Nov/Dec, pg 203, "Product Ingredients: Important Ramifications, Barbara Ann Montgomery, R.N., E.T. Debbie Broadwell offered to add a session at June Conference addressing these concerns.

The Standards Committee is working on Standards of Care of Incontience and Pressure Sores. Both will be helpful to all of us when completed.

E.T. Nurse Day will be celebrated in May during National Nurse Week (instead of during Digestive Disease week).

There will be a Pressure Sore Workshop on Friday, June 6, 1986, prior to certification exam.

Post Conference Workshop, Saturday, June 14, 1986, Sexual Therapist and Writing for Publication.

The I.A.E.T. is endorsing "Hands Across American", May 25, 1986.

To The Members:

I wanted to respond to you on the action by the Board of Directors regarding the issue of adequate labeling of product ingredients.

Your trustee brought the following motion to the Board of Directors at the

#### Semi-Annual Meeting:

"The MidEast Region requests the IAET act on the issue of adequate labeling of product ingredients."

This particular motion was defeated for several reasons. The Board felt unclear as to what specific action the MidEast Region was requesting. Secondarily, the Board did not feel that they had sufficient knowledge of this issue to make an educated decision.

This issue is one of grave concern to all professionals who utilize products which do not include labeling of the ingredients for the decision-making involved in product selection for patient care.

As a result of a sincere interest by the Board of Directors to become more informed, the following action was initiated:

- 1) Debra Broadwell, Chairperson of the National Conference Planning Committee, is planning a panel offering on this subject at the Annual Conference in June.
- Patricia Kynes, Editor of the JET, will be including additional information in the March/April JET.
- 3) If the region requests additional action, the trustee was charged to bring back more specific recommendations to the Board; such as a position statement, proclamation, etc.

I would like to reiterate the seriousness and sincerity by which the Board evaluated your request. It was unanimously agreed upon that we needed a great deal more information regarding this subject matter and that the above proaction be implemented.

\*Motion Jane Beerck moved that we appropriate \$500 to send a youth /youths to the 1986 Youth Rally. Jane Beerck moved that we appropriate \$300 for a counselor from the Mideast Region to attend the 1986 Youth Rally. Seconded by Angie Lamb. Motion carried.

\*Motion Joan VanNiel moved that \$250 be appropriated for the Norma Gill Foundation for the purpose of aiding nurses in foreign countries in receiving E.T. training. Seconded by Nancy Rioux. Motion carried.

MEMBERSHIP MEETING (CONT'D)

#### PRESIDENT REPORT

Discussion was held regarding the possibility of doing a survey to determine the average cost of ostomy equiptment per year for an ostomate. Sally Thompson agreed to help with this project.

Bonnie Bollinger requested that we work toward hiring a consultant to lead us through lobbying. This will be checked in to.

Concerns about patient care were addressed. Reference was made to the presentation made by Barbara Montgomery at the Miami, I.A.E.T. Conference re: ingredients in products used on wounds and on our ostomates. It was suggested we voice our concerns to National and hopefully have a bigger impact when approaching the manufacturers if National is behind us.

A request was made for Joyce Hawley, Regional Trustee, to take the concerns back to National re: the concerns expressed by the membership about inadequate labeling of products.

\* Motion Olga Cameron moved that the Mideast region request the IAET address the issue of inadequate labeling of products. Seconded by Rosemarie VanIngen. Discussion followed. The motion was ammended with the following wording: \*inadequate labeling of ingredients.. Motion carried.

The President requested the Secretary to prepare a letter to convey this motion to the President of the IAET, and provide a copy to Joyce Hawley, Regional Trustee.

\*Motion Bonnie Bolinger moved that we empower Ethel Pryor, President of the Mideast Region, to pursue the issue of employing a legislative consultant and if the amount should exceed the \$500.00 limit established in the bylaws, then she can seek a vote of the officers of the Region by phone. Seconded by Marilyn Spencer. Motion carried.

A request was made for Joyce Hawley to take the concerns to IAET re: lobbying.



## Allergy testing

What it is: Evaluation of skin reactions to specific substances.

Purpose: To identify which substances/ materials the patient is allergic to. Patch testing is usually done to diagnose an allergy to something worn or touched.

How to test: Hairless areas, such as abdomen or forearms, are cleaned with alcohol and acitone and allowed to dry. A patch of the substance being tested is applied to the skin and taped in place. Test sites, if more than one, are usually two inches apart. Instruct the patient to leave the patch in place, keep it dry, and remove it 48 to 72 hours later. After removal, wait 30 minutes for any reactions to the adhesive to lesson. If no reaction to the substance has occured, check the area again in 96 hours. \*In case of discomfort during the initial patch testing phase, the patch should be removed before the 48 hour contact.

#### Evaluation:

+ Positive: nonvesicular, weak reaction with erythema and edema

++ Positive: vesicular, strongly positive reaction with erythema and edema

+++ Positive: bullous, strongly positive

Assessment: Must contain relevance between history, clinical facts, and test results.

## PROPHYLACTIC MANAGEMENT OF A BELOW THE KNEE AMPUTATION

Recently a 24 year old man came to our office with a complaint of severe pain and mild erythema at the distal aspect of his stump. On discussing his past medical history and present activity level, the following findings proved relevant.

At the age of 21 he underwent a right below the knee amputation for Ewing's Sarcoma. Ewing's Sarcoma is a nonosseous origin-primary malignant bone tumor. It originates in bone marrow and invades shafts of long and flat bones, instead of ends. It usually affects lower extremities, most often femur, innominate bones, ribs, tiba, humerus, vertebra and fibula. It usually affects males, age 10 to 20 years, beginning with pain which is increasingly severe and persistent. Overall, the prognosis is poor. Various treatment regimes consist of high voltage radiation because the tumor is very radiosensitive. Chemotherapy is employed to slow the growth process and amputation is indicated only if there is no evidence of metastases.

Prior to being diagnosed and subsequently treated aggressively at the Memorial Sloan-Kettering Cancer Institute in New York City, John had pain in his right lower extremity for one year. During this year he had consulted several physicians to no avail. Once recuperated from the amputation, John was fitted with a prosthesis. Over the last 3 years, he required 4 prosthetic modifications. There was typically a 3 week waiting period between measurement and delivery of his new prosthesis.

Why did he require so many modifications? John's hobby was body building and weight training. He belonged to a local body building gym and spent several hours per week immersed in his routine. As a result of this training, his body's muscle mass continued to develop and he essentially outgrew his prosthesis.

Prior to a prosthetic modification, John would experience intense, persistent pain in his stump. The area usually developed erythema and once he developed a wound which required hospitalization. He was very frustrated because he could not wear his old prosthesis for the 3 weeks he waited for his new prosthesis. He typically became home bound and depressed.

John was referred to me by his sister who was a nurse at a hospital where I am on staff. She recognized her brother's frustration, and was cognizant of our involvement with chronic wounds and skin care. Because each physician he consulted directed him to rest during these three weeks and avoid wearing his prosthesis, she thought we would be able to offer him some alternatives.

On examination, John's leg exhibited mild erythema which measured approximately 4.0cm x 1.5cm. He complained of constant soreness. The epidermis was intact but moist secondary to perspiration. He wore an elastic nylon sock which promoted this moisture accumulation. I recommended a sock with at least 50% cotton content. Initially several treatment regimes passed through my mind, but the bottom line was he required a material which would not interfere with the prosthetic fit.

Could it be as simple as a transparent film dressing? This would prevent the friction between his stump and prosthesis; it would prevent maceration. I chose new Biodusive by Johnson & Johnson simply because of the ease of application for the patient and I gave him several samples, and requested he call me in one week.

One week later John came bouncing into my office, quite exhilerated. The erythema had resolved, but most importantly, his pain had dissipated. He has continued the use of Biodusive prophylactically and I have recommended this treatment regime for several patients with amputations since that time.

# THE INSIDE STORY IS LEAKING OUT

#### DEFECTIVE PRODUCTS -- WHAT TO DO

No doubt most of you have been victims of any number of defective products in your lifetimes. It may even happen with your ostomy products. While manufacturers strive for excellence in quality control, problems can occur. The following is the proper procedure to follow so that you and your dealer can help the manufacturer rectify the problem:

- 1) It is important that you keep the products you are using in their original boxes/packages, as the containers have "lot numbers" or "control numbers" stamped on them so the manufacturers can trace the origin of a product problem.
- 2) Be sure your product complaint is because there is a defect in the product; for example, split pouch seam, leakage at a weld, or separation of the pouch from the adhesive. It is NOT a manufacturing problem if you are stretching the wearing time of the product beyond its expected limitations. Also, many times a product is blamed when actually the problem is that the ostomate needs to see an ET for professional consultation.
- 3) It is helpful if you can explain the problem in writing, and even mark the site of the problem on an unused identical product with a marker. NOTE: It is not necessary that you return a used defective product.
- 4) Return the defective product in its original box to the dealer from which you purchased it. Your dealer is prepared to offer you a replacement product for any defective product. Some dealers require you bring your invoice (proof of purchase) with your return.
- 5) Make sure the replacement product is not of the same lot/control number as the product you've returned. This is why it is best to return the product where you purchased it, as the dealer can then check his inventory for other defective products.

It is extremely important to report defective products. Manufacturers need your input -- and yours can be the difference in their deciding what is an isolated case or a major problem. You can save others from experiencing the problem that occurred with you!


If the problem continues, your dealer should be prepared to suggest an alternative product, at least until the problem has been resolved.

Knowing what to expect and how to act when one encounters a defective product relieves some of the frustration involved.

So -- be prepared!

#### WORKING WITH SOMEONE YOU DISLIKE

No matter what the issue, you can't seem to agree with your colleague. But as health care providers in the same hospital, you have no choice but to work together.

What do you do? Staying at odds and letting the mutual dislike fester just leads to strained nerves. It also makes everyone around you uncomfortable.

The answer lies in coming to an understanding and finding a harmonious middle ground.

All disagreements between peers are the result of different work styles, insists Robert Hecht, President of Lee-Hecht and Company. "Your work style is a function of your personality", he says. People tend to agree on broad objectives and goals, but disagree on how to reach those goals.

To reconcile differences, he offers these suggestions:

Appreciate your colleague's opinion. While you may not agree with each others approach and style, respect the fact that it also has value. See issues within a perspective and don't blow them out of proportion.

Depersonalize your differences. Don't fall into the trap of attacking the person. Stick to relevant issues and put emotions aside. Question facts, not motives.

During a disagreement:

- Allow the other person to react. Hear what he or she has to say without letting your feelings interfer.
- Work towards agreement on the problem. After you both state your opinion, develop a joint statement which you both can address.

- Test your solutions. Establish a time period, monitor the program, evaluate progress, and make adjustments based on reality.

By working closely together and having ongoing dialogue concerning how goals are to be reached, you're also breaking down barriers. This will help you reach a better understanding of your colleague's work style.

#### NEWSLETTER FROM THE GOVERNMENT AFFAIRS COMMITTEE

The Newletter will be released every two months. Deadline for submission is the 15th of even months. Please send anything pertaining to your practice which could be shared. The Newsletter is dependent on everyone's input. Anything happening in your work setting which effects your goal is appropriate to report to the committee.

#### NURSE IN WASHINGTON INTERNSHIP

Excellent program. A Government Affairs Committee Member will be sent to this. It is one week long and is focused on the nurse specialty. Specifics will be obtained and mailed out to committee members and anyone interested.

#### WHAT IS AN E.T?

The committee will be sending the E.T. brochure to all federal legislators by December of 1987. We will also be sending them to the state legislators on Health and Insurance Committees by December of 1987. We hope this will make us more visible and possibly establish the E.T. nurse as a resource to them, especially when they were looking at health issues.

#### REIMBURSEMENT ISSUES OF SUPPLIES

A Task Force was set up to meet with HCFA in Washington. The purpose would be twofold - 1) Update the code for reimbursement of ostomy, pressure sore, incontinence, and wound care products. 2) Improve interpretation of codes by regional carriers/claim assessors. The particular problem of interpretation by the carriers is one area that was a concern for everybody. Therefore, the committee agreed to focus on this area. Gaymar has already agreed to provide some financial assistance towards this goal.

#### "PHONE TREE - QUICK RESPONSE"

This method was set up to pass information on and solicit support within the region when important legislative issues require a quick response.

#### COMMUNICATION

The Government Affairs Committee will have a section in the JET to share activities and concern. Please share your ideas so that we can use this as an effective communication.

#### **EDUCATION**

Setting up workshops on Legislative/Regulatory Process for 1987 meetings is our goal. The committee members will be discussing this with the Continuing Education Chairs. This will be a short presentation. The details have not been discussed.

A manual is being written.



#### GOVERNMENT AFFAIRS COMMITTEE

Our meeting was held Friday, November 7th, in Grand Rapids. Of 19 members at that time, 11 were present. We discussed several issues.

Internship in Washington: We had one letter of intent by Mary Mirkel and two other persons verbalizing wanting to attend. The March class has been filled, so we are on a waiting list.

The board membership did vote to contribute up to \$1000 toward someone attending. A fair selection process will be identified and a policy written regarding attendee committment to the O.A.C.

Reimbursement Issues: Sally Thompson shared with the committee a sequence of inquiry letters started in November, 1984. These letters address the inflexibility and inaccuracy of reimbursement of supplies. Medicare's new policies are making it difficult for retailors to accept Medicare payments. We know what that means to the patient. I have shared those letters with the National Committee and hope they will be able to use Sally's case.

Educational Presentation for Fall 1987: The committee discussed this and had several suggestions. The decision is pending a meeting with the planning committee.

Legislator Education: Olga Cameron and Diane Singer, from Harper Hospital in Michigan, shared a recent experience they had in a combined effort with a nursing school. They invited legislators to an open forum and discussed current issues. The committee discussed outlining what steps they followed and sharing it with the membership as a good way to educate the legislators.

# Readers write

Did you know...

...extended release Pronestyl (Procainamide hydrochloride), an antiarrhythmic agent, is prepared in a wax matrix which is not absorbed but expelled with feces. The waxy base maintains its shape and may cause obstruction in some ostomy patients. The problem was noted in an elderly patient with a sigmoid colostomy and radiation colitis admitted with symptoms of bowel obstruction. When the colostomy was irrigated, 6 white "football" shaped tablets were expelled. A medication review, use of P.D.R., and consultation with the pharmacist and drug representative solved the dilemma. A change in medication was discussed with the physician.
