NEW SCHOLARSHIP PROGRAM

The IAET is pleased to announce a new scholarship award program for ET nurses who are working toward an advanced degree in nursing. Scholarship recipients are selected by blind review based upon applicant merit, financial need, and compliance with the basic eligibility requirements set forth by the IAET Scholarship Committee. Applications are available from Central Office beginning March 1, 1987. Completed applications must be received by IAET Central Office by no later than July 15, 1987 for the 1987/1988 academic year.

Applicants must meet the following criteria to be considered eligible for financial assistance and application review:

- 1. Currently seeking a baccalaureate, master's, or doctoral degree in nursing.
- 2. Graduate of an IAET accredited ETNEP.
- 3. Board Certified in ET nursing.
- 4. Current and active member of the IAET.
- 5. Provide proof of current enrollment or acceptance into an NLN accredited nursing program (full or part time) entering either junior or senior status.
- Have a 3.0 grade point average (GPA) in all academic work undertaken.
- Provide proof of current or previous employment as an ET nurse.
- 8. Have at least 2 years of ET nursing experience within the past 5 years.

RESEARCH

The IAET Statement of Ethics in research related to ET nursing practice is now available through Central Office. This 29-page document will be sent to members upon request, to IAET board members, and individuals applying for IAET research grants.

The first IAET Annual Nurse Research Lecture will be presented this year at conference.

The Research Committee is in the process of developing an IAET research grant that will support nursing research relevant to the practive of ET nursing at the doctoral level.



CLINICAL INVESTIGATOR GRANT (CIG)

Criteria:

- The principal investigator must be a novice or beginning researcher, preferably a nurse with a current clinical practice.
- The nature of the research topic should be related to clinical practice of ET nursing.
- The principal investigator may not be conducting the research as part of completing a degree program (BSN, MS, or PhD).
- The principal investigator must be a member of IAET.
- It is not obligatory that funds be granted.

Financial Considerations:

 The principal investigator will receive up to \$1,000 for the grant based upon a submitted budget.

Six members of the GAC will be attending the Nurse in Washington Internship March 8-14. This is a project sponsored by the National Federation of Specialty Nursing Organizations (NFSNO). Three regions, one company, and the IAET are assisting with scholarship funds.

April 9th and 10th are the dates of the HCFA Coalition Meeting to be held in Washington. This meeting is being organized to include relevant organizations and industry representatives who have a direct interest in the HCFA proposed regulations on "Lowest Charge Level". The objectives of this meeting are to:

- obtain a briefing on the current status of the proposed regulations,
- develop a consensus among the relevant interests on the issue,
- develop a plan of action.

ConvaTec will be partially underwriting this meeting. The importance of this meeting includes the following:

- it is the first time that the ostomy community has had an opportunity to build a "coalition" of interest,
- it will begin the process of creating an information network for any future governmental regulatory activity,
- it may be the first ostomy issue that can be discussed as a public relations issue with the general public.

VIRUS His-and-Her Cancers VIRUS LINKED TO GENITAL CANCERS

"If you're his 21st lover, you could be at risk"...

Women are five times as likely to get cervical cancer if their steady sexual partner has had 20 or more lovers. That's the curious finding of an epidemiologic study.

Previous reports have shown that women who smoke and who started having sex early and with numerous partners face a high risk. But the new study by epidemiologist Maria Zunzunegui of the University of California, Berkeley, is among the first to suggest that a woman's chances of getting the cancer also depend largely on her sex partner's habits.

Dr. Zunzunegui compared the smoking and sexual histories of 39 San Francisco women with cervical cancer, and their mates, to 39 matched couples with no cancer history. Her findings, reported in the <u>American Journal of Epidemiology</u>, support new theories that cervical cancer and other genital malignancies can be sexually transmitted, probably by three variants of the human papilloma virus (HPV). Most of the other 38 known HPVs cause non-malignant skin and genital warts.

According to the latest thinking, people who've contracted HPV through intercourse with infected individuals can pass the virus' genetic material on to others.

NATIONAL YOUTH RALLY

July 2-6, 1987 San Diego, California

We are planning to have around 80 teenagers (12-17 year olds who have had colostomy, ileostomy, or urostomy surgery) from all over the United States and Canada participate in this event. The purpose of the Rally is to provide rehabilitation to the young ostomate through increased knowledge of his or her ostomy, increased social growth, and increased independence.

There will be many scheduled activities such as a trip to Sea World, a dance, pizza party, swimming and other sports, and sessions that will deal with such things as self-image, sexuality, and personal hygiene. Many of these youngsters have never been away from home before and have had over protective parents. The dorm setting reassures many of them (including those wheelchair bound) that college life is a possibility for the future.

The UOA is a non-profit organization. The counselors and E.T. nurses donate their time to work with the youth and sometimes attend at their own expense. There will be one instaff psychology counselor, one E.T. nurse, and one UOA counselor for every 10 teenagers. One E.T. nurse will be added for every three disabled youths.

"ET" NURSING OFFERS EXCITING NEW CHALLENGE

The following article appeared in the Summer, 1986, issue of <u>Cancer</u> <u>Nursing News</u>. As ET nurses, we appreciate the support of the American Cancer Society...

Enterostomal therapy (ET) nursing has undergone a dramatic expansion in recent years, in terms of both the scope of practice and the number of nurses specializing in the field.

No longer limited to ostomy care, the role of the modern ET nurse has evolved to also include three new areas: wound drainage and care of fistulas, incontinence care and counseling, and management of pressure sores.

"All three areas are outgrowth of the ET nurse's original role in stoma care," explains Linda Klein, President of the International Association for Enterostomal Therapy (IAET) and an ET nurse at the Veterans Administration Medical Ceter in Kansas City, Missouri.

"For example, since an important part of stoma care is the prevention and treatment of skin breakdown around the stoma, it was only logical for ET nurses to apply those same skills to the prevention and treatment of other skin problems, such as pressure sores, and to the control of incontinence, the cause of other skin irritations."

Attention to Nutrition

Because of their experience with stomas, ET nurses have also become knowledgeable about nutrition. "Any type of wound takes much longer to heal if the patient is malnourished," Ms. Klein notes. "ET nurses, therefore, now collaborate with dieticians and physicians to help maintain the proper nutritional balance of patients recovering from any v surgical procedure."

Along with the knowledge gained from their care of ostomy patients confined to bed, ET nurses have learned about specialized types of equipment, such as air-flotation and air-fluidized beds and mattresses that help relieve the pain of pressure sores and promote healing.

"ET nurses keep up-to-date on the newest technological advances in care, from special creams and supplies to highly sophisticated pieces of equipment, and they are often called upon by industry to evaluate these products," she said.

Cost-Effective Care

ET nursing has been found to be highly cost-effective. "Studies show that when an ET nurse is involved in the care of an ostomy patient, hospitalization is decreased by an average of three days," Ms. Klein points out.

"In addition, because the ET nurse can coordinate use of equipment and supplies, there are important cost savings to the individual institution. Studies have also found that patients treated by ET nurses experience fewer complications."

The number of ET nurses has grown considerable in recent years. In 1976, for example, the IAET had 250 members, compared with the current membership of 1,900.

ET nurses are registered nurses with a baccalaureate degree in nursing. One year of recent clinical experience is required prior to enrollment in an IAET accredited enterostomal therapy nursing education program. Those

who have completed the program are then eligible for Board Certification, which is subject to renewal every five years.

Highly Marketable Skills

. .

ET nurses work in a wide variety of settings -- acute care facilities, nursing homes, home and health care agencies, clinics, and private practice. In rural areas and smaller cities, many ET nurses contract their services to several institutions and agencies.

"Of all the nursing specialties, enterostomal therapy provides one of the most marketable skills," she says. "The specialty also enjoys a high degree of acceptance by surgeons, nursing administrators, and other members of the health care team."

A DEFENSE AGAINST CANCER CAN BE COOKED UP IN YOUR KITCHEN

There is evidence that diet and cancer are related. Follow these modifications in your daily diet to reduce chances of getting cancer:

- Eat more high-fiber foods such as fruits and vegetables and whole-grain cereals.
- 2. Include dark green and deep yellow fruits and vegetables rich in vitamins A and C.
- Include cabbage, broccoli, brussels sprouts, kohlrabi, and cauliflower.
- 4. Be moderate in consumption of salt-cured, smoked, and nitrite-cured foods.

Evidence: Among American women, the viral DNA is found in 85% of cervical cancer cells, according to an unpublished consensus report of an American Cancer Society research committee.

Genetic material from two types of HPV not normally associated with genital or cervical cancer has been detected in semen of three patients with severe chronic wart disease, a University of Minnesota team reports. Although the small study in the journal <u>Science</u> raises the possibility the HPV is transmitted in semen, many more patients must be checked to prove the suspicion.

Most researchers now believe the virus is carried in penile-skin lesions or in the cervix, says ACS past president Saul B. Gusberg. "It's now a dictum that if you find this virus in the woman you should examine her sexual partner or husband as well," he says. Though penile cancer is rare in the U.S., small studies of couples in England, Germany, Puerto Rico, and Brazil show that the HPVinfected men also face a risk of cancer.

Pap smears for early detection of cervical cancer are simple procedures, but testing men for HPV is more complicated. It involves internal examination of the urethra, where viral particles hide.

"We don't know why we're not seeing more HPV-related penile cancers in the U.S.," says Dr. Gusberg. "But we believe the virus and increased promiscuity in both sexes are responsible in part for the sharp increase in abnormal Pap smears we're finding for women in their 20s."



The Mideast Region GAC has 25 members and all members are on a phone tree for important state and federal issues. You. as a member of the Mideast Region, may be called by a GAC member to call or write your legislature to vote for or against a proposed piece of legislation. We can make a difference! If federal legislators receive 40 letters on an issue or 200 letters on a big issue - this response is enough for them to support or change their minds on an issue. And for state legislature - they only need 5 letters. A hand written letter will also get а legislator's attention more quickly than a typed letter or form letter.

Nancy Faller, chairperson of the national GAC, encouraged participation by GAC members and other ET nurses with the

National Federation Speciality Nurses Organization (NFSNO) on a state level, or if the NFSNO is not active on a state level - to network with other nurse specialists. Goals of networking include: monitoring state and federal legislation; sharing clinical information; co-sponsoring educational programs; increasing recognition of the specialty of ET nursing; and developing political influence through banding together on issues.

Six ET nurses attended the Nurse Internship one week program in Washington, D.C., in March, 1987. These six nurse interns and other ET nurses from the Mid-Atlantic region with UOA members, <u>hand-delivered 500</u> ET nursing brochures and an introductory letter by Linda Klein to "all" of our federal legislators on May 6, 1987 -- ET Nurse Day. This project helps to meet a goal of, the I.A.E.T. and the GAC: to increase understanding of ET nursing and to increase our visibility among other health professionals and the public.

For the 1988 I.A.E.T. Conference in Dallas, the national GAC will present an The session will educational session. probably introduce the new H.C.F.A. (Health Care Financing Administration) codes for reimbursement of ostomy supplies. the Currently, coding system for reimbursement of ostomy supplies has on "sex" codes for describing all of our ostomy supplies. The ostomy supply codes are now being updated and expanded through a Task Force consisting of I.A.E.T. and U.O.A. members, the ostomy and manufactures. The projected date for completion of the ostomy H.C.F.A. codes is December, 1987. After the codes are revised, education of ET nurses, the E.T.N.E.P. programs, and the insurance carriers will be needed. The educational session in Dallas by the national G.A.C. may be presented by several of the ET nurses who attended the Nurse Internship program. * An important note: Two of the ET nurse interns from the March 1987 program were the individuals who brought the coding problem to the attention of the **B.C.F.A.** officials in Washington, D.C. These two ET nurse interns also presented the H.C.F.A. officials with the initial draft of the solution for revising the codes!

The Mideast Region has a reservation for the Nurse Internship program in 1988. The Mideast Region has previously approved \$1000 to support sending one of our members to the one-week program. There are several candidates that are currently being considered, however, it is not too late to write or call me if you are interested in the Nurse Internship program. The deadline for submitting the name of the person to Nancy Faller is rapidly approaching, so if you are interested, don't hesitate to notify me.

Our regional G.A.C. is planning an educational offering at our Mideast Region meeting in November, 1987. The Mideast Region G.A.C. will also have a committee meeting - specific details will be provided in the next Mid-Eas Dropper. New members are welcome!


It was interesting in that we brought pouches and a mechanical model of a human and demonstrated the anatomical aspects of the ostomy.

Support Groups

The Southeastern Michigan ETs and ostomy specialists have met twice this year for very informative programs.

Ethyl Pryor coordinated an afternoon program on February 12th at Henry Ford Hospital. Ralph Pearlman, M.D., Fellow in the Colon/Rectal Surgery Department at HFH, presented a paper on the local treatment of rectal radiation and transanal resection. The patient population treated at HFH also reflects an increase to 26% the number of patients with cancer of the cecum and ascending colon. It is not known yet if this is a true increase or just better The American Cancer Society detection. reports a 14% incidence of cancer of the cecum and ascending colon. Dr. Thomas Fox, Jr., Division Head of Colon/Rectal Surgery at HFH, also presented information on a new biodegradable bowel anastomotic ring that is currently being tried. Three hundred rings have been used successfully in patients. The greatest advantage in the use of this ring is ease of application at anastomatic sites and an approximate 15 minute decrease in operative time as compared with the use of the EEA stapler. Dr. Donald Ditmars, Division Head of Flastic Surgery, then gave an interesting presentation of problems with chronic wound healing. A discussion followed regarding what ET nurses recommend for chronic wounds along with a slide sharing session of problem wounds. Thanks Ethyl for a great afternoon!

On April 15th, JoAnne Aldrich, Teri Boyd, and Pat Freeman organized our Spring meeting at St. Lawrence Hospital in Lansing, Michigan, Dr. D.K. Johnson, F.A.C.S., a urologist on staff, gave an interesting and informative presentation on the or "Indiana continent urostomy Pouch"...also known as the ceco-ileal This is a continent urinary reservoir. bladder-like reservoir that is continent, low pressure, nonreflexing, and does not require an appliance. He stated that the Koch continent urinary pouch as a 30% re-operation rate and uses a lot of bowel.

This surgery takes 4-5 hours and the right side of the colon and ileum are used as the pouch, including the ilealcecal valve. The stoma is flush and can be located anywhere on the abdomen. Pat Freeman, RN,ET, then discussed the postoperative nursing care in regards to catheterization and irrigation procedures with these patients. It was helpful to know that this procedure is being done, as well as at the University of Michigan Hospital in Ann Arbor, with a good success rate. You can read more about this surgery in the <u>World</u> <u>Journal</u> of <u>Urology</u> (1985)(3)185-190 "The Cecoileal Continent Urinary Reservoir" by R.G. Rowland, M.E. Mitchell, and R. Bihrle. Dr. Johnson then stayed for our slide sharing session that helps us all learn what is being done for ostomy/wound care patients in our respective hospitals.

A July meeting is planned at Mt. Carmel Hospital, hosted by Julianne Stroud, to share highlights of the Las Vegas convention and a workshop on AIDS prevention focusing on "Safe Sex" for men and women.



a. Submit an item for publication in each issue of JET & all regional newsletters: Don't forget, you can use any information in this newsletter. We need to keep our colleagues informed.

b. Offer workshops on the legislative/regulatory process in each region by fall '87: Please let me know if this has been accomplished.

3. LEGISLATORS

a. Send ET nursing brochure to all federal legislators by 12/87; Please let me know if you sent the follow up letter to your legislators.

b. Send ET nursing brochure to all state legislators on health & insurance committees by 12/87: Because there is now a minimum charge for the brochure, I need to budget for these copies. Thus, I need the numbers for each region. I only have two. Please respond by mid-October.

c. Write legislative platform/policy statement: This has been sent to Pam Mittelstadt (our ANA consultant) for her input.

4. HCFA

Set up a task force to:

a. Update the codes for reimbursement of ostomy, wound, & incontinence products (Barb)

b. Improve the interpretation of codes by regional carriers/claim processors (Jill)

The final draft was sent to HCFA. We should have a response by early September. At the Executive Working Session, we will be discussing how to proceed with wound & incontinence products.

LEGISLATIVE/REGULATORY ALERT

• The Federal Employees Health Care Access Act (HR 382) will allow nurses to be reimbursed for services they are licensed to perform, that are covered under the Federal Employees Health Benefit Plans. A similar bill has been introduced in the Senate by Mikulski (D-MD): S1162. Letters of support are still needed.

• The Promotion of Equitable Pay Practices Within the Federal Civil Service Act (HR 387 & S 522) calls for a study of federal employees to determine if there is sex or race based discrimination in the setting of wages or in job classifications. This bill was reported out of the Compensation & Employee Benefits Subcommittee of the House Committee on Post Office & Civil Service. It will be referred to the full committee. The Senate Federal Services, Post Office & Civil Services Subcommittee sent this bill to the Governmental Affairs Committee. It is expected to be sent to the full Senate after the August recess.

• Nursing Home Quality Care Ammendments (S1108 & HR 2270) propose reforms in the areas of resident assessment, surveys, resident's rights, & nursing aide training programs. The House Energy & Commerce Committee reconcilation package (HR3188) contained various provisions aimed at improving the quality of care in Nursing Homes. A comprimise was reached on the staffing issue regarding nursing coverage: 16 hour RN coverage with 90 beds or more and 8 hours with 90 beds or less.

• S1299 which would amend the McCarran Ferguson Act to repeal the anti-trust immunity in the insurance industry was introduced by Metzenbaum (D-OH.) A similar piecs of legislation was introduced in the House (HR 2727). The ANA continues to support this repeal because it would prevent the industry operation outside the view of government. One insurance company has agreed to cover nurse practitioners, unfortunately they will not cover mid-wives, anesthetists, or NPs in private practice.

• Nursing Shortage Reduction Act (S1402) would provide: (1) an advisory committee to identify solutions to recruitment & retention; (2) projects to demonstrate improved long term care practice; (3) grants to develop innovative nursing practice models; (4) establishment of nurse recruitment centers. Senator Kennedy dratted this legislation to addresses the current nursing shortage. It was passed by the Senateon Sugust 5.

• Glenda wrote a position statement supporting Medicare coverage for air-fluidized bed therapy in the home for patients who have had reconstructive surgery for pressure ulcers. HCFA plans to make a coverage decision in the near future.

• Medicare Community Nursing & Ambulatory Care Act (HR 1161) would allow community-based nursing organizations to provide services for Medicare Part B beneficaries on a prepaid, capitated basis. This legislation has been included in the reconciliation package (HR318B.)

• HR3046 would mandate certain hospitals and ECFs to provide free Hepatitis B vaccine to workers at risk.

<u>NEWS</u>

• The Michigan nurses have organized a unique Project: MUSCLE, Mobilize & Unite to Strategically Confront the Legislative Establishment. They are planning a two day event in September. Nurses will have a chance to meet their legislators to discuss current issues. In addition, they will have time to talk with one and other about proposed changes in health care. They hope to increase political awareness, while at the same time highlighting the collective power of nurses. Olga Cameron, a member of the MidEast region, plans to use this opportunity to educate about ET nursing.

• Carole VanNess has been in liason with the *Coalitiion of Nursing Organizations in California*. They meet monthly. Focus topics have been the nursing shortage and legislative issues. In addition, Carole has distributed a flyer containing suggestions for meeting with legislators. I am enclosing a copy. This is the kind of information that will be included in the manual.

• Nurses in Florida were influential in the Senate race. In large part due to their unrelenting support, Governor Bob Graham defeated incumbent Paula Hawkins. (The Political Nurse, ANA)

• Donna Felling is a Maryland nurse, who was newly elected to their General Assembly. In response to her success she notes: "I wish there were some way to get the message across to nurses that this can only happen when everyone gives a little bit of their time. They must offer it themselves - they can't wait for someone to ask them. It would make all the difference in the world if more nurses became involved." (The Political Nurse, ANA)

• The DDNC (Digestive Disease National Coalition) is attending meetings of the Prospective Payment Assessment Commission to monitor changes in the DRG (#179) for Inflammatory Bowel Disease.

Congressional recess is Aug 7 to Sep 8. Plan to have letters waiting when your legislators return to DC.



Once completed, the Blueprint will provide the Association with the data and projections to enable us to determine the actions needed to ensure the future of E.T. Nursing and position us to meet the health care environment of the 90's, (this information taken from Odds & Ends III - September 29, 1987, Glenda Motta).

I hope all of you have received your copies of "Dermal Wounds: Pressure Ulcers", "Dermal Wounds: Leg Ulcers", "Urinary Incontinence", and "E.T. Nursing Practice".

This information that I am sharing with you is all new since I turned in my report on October 1, 1987, for the Regional Meeting.
