ANNUAL BOARD MEETING October 27, 1988 Charleston, West Virginia

The meeting was **called to order** at 1:10 p.m. by Shirley Alltop, President.

Quorum determination was made by Parliamentarian, Bonnie Bolinger. (Attendance roster placed on file with minutes.)

Secretary's report was presented by Deanna Peters. Addition was made to the last board meeting minutes: "Semi Annual Board Meeting rather than Annual. Question/clarification of page 3 re: Bylaws. Explanation, the "affiliate" decision was never brought to a vote. This concern was discussed at the November 6 - 7meeting, and discussed at the February 1988 special board meeting. The minutes were accepted with the addition. Motion to accept the minutes made by Sharlene Kennedy. seconded by Karen Granby.

Treasurer's Report was presented by Betty Petrey. The Financial statement was presented (see attached). Mention was made of a letter received from Fred Droz from the IAET re: his concerns for the Region's investments. Mideast Suggestions for "safe" arenas were presented (letter placed on file). We must follow the IAET guidelines in order to maintain our tax exempt status. The board recommended that additional contacts be made with National by Betty for further clarification and recommendations.

Bylaws: Rosmarie VanIngen Discussion held re: Honorary Member. Questions: 1) Does this person need to be a member of the MidEast Region? 2) Does this person have privileges? voting Further discussion and was held the following wording suggested to better clarify the intent. Honorary Member: Honorary membership to the MidEast Region may be conferred upon individuals who have been recommended general bу the membership and approved by the Board of Trustees. Those honorary members who are active members when honorary membership is conferred will retain all the privileges of active membership. This recommendation will be printed in the MidBas Dropper and voted upon in June, 1989.

Governmental Affairs Committee Olga Cameron - The GAC report was presented (see report). Presentation of a "draft" job description for the GAC Chairperson was submitted for consideration. Letters were sent by the GAC Chairperson to seek candidates for the scholarship to Nurse Internship in Washington. There was no response from any of the present committee members to attend. Individuals who had indicated an interest were Shirley Alltop and Sharon Ballard. Shirley has since withdrawn her name as a candidate. There is a \$350 fee for registration. Discussion was held regarding the importance of the candidate having a "fact sheet" in order to be fully informed of issues/concerns of the membership

and therefore be prepared to discuss those concerns. A recommendation was made to present a written proposal as to the term/function of the GAC chairman, to assure continuity of the functions and goals of the committee. This proposal will be submitted by Olga Cameron for further consideration.

MOTION: Moved to add \$50.00 each year to the GAC budget to cover the cost of the luncheon fee when attending the State Nursing Coalition Meetings. (Motion by Olga Cameron, seconded by Sharlene Kennedy...motion carried)

Trustee/Fundraising - Barb Montgomery - Items to be sold and raffled were presented. A suggestion was made for the Region to consider an auction as a future fundraiser.

Nominations - Brenda Kershbaum -Presentation of the 1988 slate of candidates presented was (see report). Montgomery Barbara withdrew her name for consideration as Regional Trustee. Any names for consideration as Regional Trustee should be submitted to Brenda Kerschbaum. The individual must be a board certified ET nurse, and must have served on the MidEast Region board for one term.

Operations Manual - presented by Rosemarie VanIngen The President-Elect will hold the "master CODY" and wi11 be responsible for updating the manual on an ongoing basis. The revisions will be presented by the Operations Manual committee to the board for discussion. The President-Electwill chairperson of serve as said committee.

Publications - Barb Hocevar - Goals achieved were presented by the committee. Current problems encountered were outlined: 1) Mailing labels to be updated on an annual basis. 2) Question regarding who is to be provided with mailing

labels and whose responsibility is it to release those names? (Newsletter or Membership) It was mentioned that the Newsletter is set up in a format that easily could provide a roster of names that could be xeroxed. This committee would provide a roster, not labels. A recommendation was made to obtain (one time per year) labels from the IAET. This list would need to be double-checked by the newsletter chairperson for accuracy. 3) It was mentioned that Bylaw changes will be printed in the newsletter, not the entire packet of bylaws because it is too bulky. 4) Various logos were submitted for approval to be used for the MidEas Dropper logo.

Newsletter Ads - Sharlene Kennedy -Suggested that a fee be set per year to eliminate confusion regarding the when ad fee expires. Α suggestion was made to contact the regional managers for the companies being solicited for an ad in the Mention was made that Dropper. Coloplast will be submitting new ad copy for print along with a check for \$200 for one year of advertising in the **Dropper**.

Sharon Ballard expressed her desire to become more politically involved and to be considered as recipient of the scholarship for the Nurse in Washington Internship.

MOTION: Olga Cameron moved to nominate Sharon Ballard to attend the Nurse in Washington Internship program for the year 1989 (seconded by Deanna Peters, motion carried).

Regional Trustee Report - Joyce Hawley - Presentation of the various National issues were shared. A revised position statement by the IAET was presented as follows: Any member receiving compensation for services, other than education or research, from a manufacturer of any product related to the practice of ET Nursing or a firm providing services to the IAET, may not serve on the IAET Board of Directors. This requirement applies only to the Board members elected/re-elected after January 1, 1989.

A "task force" has been appointed by National to define Education & Research issues that may be considered a "conflict of interest" (see Joyce's report).

The IAET Membership Committee has been merged with the Public Relations Committee.

The "blue-print" survey results have been reviewed and will be made available to the membership in the future. Joyce will extract various items of interest and present to the MidEast membership during our Membership meeting.

Concerns were expressed by the Regional board that topics for National meeting need to be selected more carefully to better meet the educational needs for its members.

Survey indicated the following average annual ET wages:

The Board Meeting will be Saturday and Sunday, January 14-15, 1989, and I will give a full report on the meeting in the next Dropper.



ANTIBIOTIC-ASSOCIATED DIARRHEA & COLITIS (CLOSTRIDIUM DIFFICILE PSEUDOMEMBRANEOUS COLITIS)

Joe White, M.D., Gastroenterologist MidEast Regional Conference, 1988

Spectrum of disease severity: benign, self-limited systemic toxicity, life threatening History:

1. pre-antibiotic era: fulminant disease with fever, abdominal pain, ileus, irreversible shock and death via intestinal ischemia, diagnosed at autopsy.

2. early antibiotic era (1950-1960's): serious illness with fever and diarrhea, variable course and outcome, dur to Staph aureus, diagnosed by stool culture and gram stain, and treated with oral vancomycin.

3. present antibiotic era (1970-present): diverse clinical presentation, histology, course and outcome, generally good prognosis, caused by C. Difficile toxin, diagnosed by culture, toxin assay, and/or endoscopy, and treated with oral vancomycin or metronidazole.

Clinical features: Watery diarrhea, crampy abdominal pain, feber, and leukocytosis. Onset of symptoms may be during or up to three months after cessation of antibiotics. Symptoms last 10-14 days with conservative treatment and 2-4 days with vancomycin therapy.

Antimicrobial agents account for 95% of cases:

All antibiotics have been implicated, though the most common are cephalosporins, ampicillin, amoxicillin, clindamycin and lincomycin. Allow for overgrowth of C. difficile.

Potentially transmissable:

Environmental sources include toilets, bedpans and hospital floors. Nosocomial outbreaks reported. Isolated from hospital personnel. High prevalence of C. difficile in family contacts.

Pathology:

Classic pseudomembranes appear 2-8 as elevated, mm, grossly cream-colored plaques superimposed on a red, friable, edematous mucosa fibrinoid and are composed of material. granulocytes, and epithelial debris. They are usually confined to the rectosigmoid, but may involve any part of the colon.

Differential diagnosis includes infectious diarrhea, inflammatory bowel disease, irritable bowel syndrome, ischemic colitis and a host of others.

include Complications dehydration, electrolyte disturbances, hypoalbuminemia, hypotension, anasarca, fulminant colitis, toxic megacolon, sepsis and colonic perforation. Mortality 15-30% overall if untreated, especially in those over 60.

Management:

1. general measures-discontinue the implicated antibiotic, use IV fluids, bowel rest may be necessary, lactose-free diet, avoid anti-peristaltic agents (e.g., Lomotil, Imodium), enteric precautions.

2. eliminate the organism:

a) oral vancomycin (125-500 mg. QID x 7 days) is the gold standard with 97% response rate but is very expensive and associated with a 20% relapse rate.

b) metronidazole, preferably orally (250 mg. QID x 10 days) has equivalent efficacy and relapse rate a vancomycin. It can be given IV and is much more economical.

3. eliminate the toxin--anion exchange resins, likecholestyramine (4 gm TID x 7 days), bind toxin but don't eliminate the organism. Not a first-line agent, but may be very useful in preventing relapse.

4. surgery--rarely needed, but may be necessary in setting of a complication.

Did you know that pressure relieving devices are classified as durable medical equipment and as such are reimbursable for home use under Medicare Part B? Items are covered when it is clearly established that they serve а therapeutic purpose or there is medical evidence indicating that an individual is "highly susceptible" to pressure ulcers. In these cases.

PREVENTATIVE USE OF PRESSURE RELIEVING DEVICES WILL BE REIMBURSABLE.

In establishing medical necessity for pressure relieving devices, the evidence must demonstrate that the item is included in the physician's course of treatment and a physician is supervising its use.

"Odds & Ends" excerpted from memo of February 16, 1989 by Glende Motter, RN, MPH, ET President of the National Federation of Specialty Nursing Organizations

The educational program provided an update on the HIV and Hepatitis 8. Here are the highlights:

--Hepatitis B is on the rise and is transmitted the same as HIV (exposure to infected blood, sexually, perinatally).

--Only 50% of high risk health workers are vaccinated against Hepatitis B. --The vaccine works; Hepatitis B can be fatal.

--Hepatitis B and HIV are not transmitted via casual contact, air, food, water, insects, environmental survaces.

--The rate of transmission of HIV in health care workers is very low.

--The chance of infection is 0.5% if stuck with a needle contaiminated with the HIV virus; 26% chance of infection if stuck with a needle contaminated with Hepatitis B.

--215 deaths per year from Hepatitis B; 12,000 cases per year (50% are asymptomatic); chronic carriers get liver disease or cancer.

--CDC has a number of educational activities to reduce the risk of infection. --Draft OSHA Standards for blood-borne pathogens will be published soon in the Federal Register for comment.

LEGISLATIVE/REGULATORY ALERT:

Bureing Home Beform Law of 1987. Nurse staffing requirements call for an RN on duty seven days a week with licensed nurses around the clock. There is a waiver of this requirement which has been strongly criticized by the ANA. New quality of care standards included pressure ulcers in response to comments made by the IAET.

Managed Hurse Education Act of **1989** S95. introduced by Senator Inouye (D) Hawaii, would establish scholarship programs allowing professional nurses to obtain advanced deprees in professions relating to the practice of nursing. S115 provides Nurse Practitioners or Clinical Nurse Specialists to be direct providers of Part B Medicare beneficiary and а mandatory of Medicaid. This was introduced by Senator Inouye also.

Family and Medical Leave Act, reintroduced in the Senate by Dodd (D) Connecticut will be introduced also into the House. This allows for parental leave for birth, adoption or illness of a child and will also allow for the care of the dependant elderly.

The Pay Equity Bill was reintroduced with major changes. HR41 (House) and S16 (Senate) calls for the Secretary of Labor, through its Women's Bureau to disseminate information on the problems caused by wage discrimination and pay inequities and to develop techniques identify to and elinate wage discrimination.

Catastrophic Health Care Bill when fully implemented, is estimated that 22% of the beneficiaries will use some of the new benefits. This bill has had its problems and a coalition of the elderly is opposing it because of the increased premiums.

Long Term Care is being redrafted for legislation introduction in the 101st Congress.

Budget '89: There is NO money in the Bush budget for nursing education!

Medicare Cut: FIVE BILLION DOLLAR REDUCTION. This is bound to have a big impact on many of our patients.

PRESSURE ULCER CONSENSUS CONFERENCE Olga V. Cameron

The Pressure Ulcer Consensus Conference as held on March 1-3. 1989, in Washington, D.C. to focus attention of researchers, clinicians, health policy makers and organizations the financing on. prevention and management of pressure ulcers.

The Congressional Receoption allowed for an informal meeting of legislators, aides and professionals from across the country. The next two days were filled with testimony, discussion and deliberation to determine the impact of pressure ulcers on the health care system. Abstracts were presented by various disciplines focusing on prevalence and incidence. epidemiology, cost-including methodology, risk assessment and research.

The participants then divided into three groups: acute care settings, long-term care, and home care, to answer questions related to abstracts and pre-set questions, with recommendations shared with the entire group and the panel of exerts.

The panel then drafted conclusions and recommendations as follows:

1. Pressure ulcers are a significant problem and a source of considerable human suffering.

2. Current classifications and descriptions of pressure ulcers are confusing and inconsistently utilized in much of the current pressure ulcer literature. The panel recommends adoption of а uniform staging system.

3. Expert opinion suggests that reimbursement issues adversely influence the performance of risk assessment and early intervention.

4. Minimum cost estimates indicate the cost of treatment of pressure ulcers adds significantly to the financial burden of patients, families, institutions, and health care payment system. Additional research must be funded to better determine the costs of prevention and treatment.


5. Clinicians and researchers must work together to develop practical methods for prevention and treatment of pressure ulcers.

6. More detailed discussions, possibly as consensus conferences, are needed to address in sufficient detail, the preventive and treatment aspects of pressure ulcers.

7. Systematic surveillance methodologies and reporting mechanisms which are appropriate for specific types of institutions need to be developed, tested, and disseminated.

8. Current and developmental bioengineering methodologies should be explored for application to diagnostic prevention and treatment aspects of this significant problem.

9. A paucity of reliable, generalizable data indicate the need for a major investigative initiative into pressure ulcers.

Wound Debridement by ET Nurse

1. Description:

Removal of necrotic devitalized tissue by sharp debridement by ET Nurse after validation of technique by on-staff plastic surgeon.

2. Rationale for wound debridement:

- a. Necrotic debris is a source for bacterial overgrowth.
- b. Necrotic devitalized tissue retards wound healing.
- c. Necrotic tissue (eschar) offers no protection to underlying tissue.
- d. Necrotic devitalized tissue may mask underly ing fluid collection of abscess that is not evident on clinic exam.

3. Assessment

- a. Presence of eschar (slough or dead tissue, usually hard, varies in color from dark yellow to green to black).
- b. Peripheral erythema (presence of inflammatory process around wound) accompanied by increased heat, swelling and pain indicating underlying tissue death.
- c. Palpable underlying induration may indicate deep tissue death not evident of visual exam.
- d. Deeply pigmented areas adjacent to necrotic tissue may indicate abscess formation or underlying fluid collection.

4. Technique

- a. Instruments:
- 1. Adson forceps with teeth
- 2. #3 scalpel handle with #10 and #15 blades
- 3. Two mosquito clamps
- 4. Silver nitrate sticks
- 5. Surgicel of Gelform
- 6. Gauze sponges
- 7. Curved iris scissors
- 8. Normal saline

9. Gloves 10.Sterile towels

ETC.

- b. Set up sterile field.
- c. Cleanse wound area to be debrided, and sur rounding area, with normal saline.
- d. Using pick-up forceps, lift edge of eschar or non-viable slough, and cut with scalpel or use ins scissors to remove. Cut with care in thin layers to prevent intrusion into viable tissue (pain and bleeding are indications of viable tissue).
- e. It is not necessary to debride all necrosis during one procedure. It is best to repeat daily until wound is clear of necrosis.
- Control of bleeding: Small areas may be touched lightly with silver nitrate to cauterize. Larger areas may use direct pressure with sponge for 5 minutes. If bleeding continues, apply Gelfoam or Surgicel and pressure dressing for 1/2 hour.
- g. After debridement, pack wound with soaked wet-to-wet sponge dressing (if wound is very deep, use roller gauze to prevent loss of sponge) or appropriate dressing.

5. Assessment of adequate debridement

- a. No odor
- b. No pus/drainage
- c. Formation of healing granulating tissue at depth of wound

6. Precautions

A non-healing chronic wound may need plastic or surgical consult to assess situation if:

- a. Abscess is found
- b. Major vessels are encountered
- c. Bone is visible at depth of wound

7. ET Nurse is to be validated yearly

No wound is too big for resourceful nurses

Combining an occlusive transparent dressing and a suction system meant greater patient comfort and a better way to treat the wound. By Margaret Wooding-Scott, RN, CCRN, Barbara Ann Montgomery, RN, ET. and Deborah Coleman, RN, MS, CS

We were disturbing Mrs. Davis for the third time this shift to change the soaked dressing over an abdominal wound too large for any pouch. The bed linens would have to be changed again, too.

As I gently pulled back the covers, Mrs. Davis opened her tired eyes for a moment. Intubated and on the ventilator, her look communicated her fatigue and resignation as surely as if she'd shouted. She had spent the last three months fighting to survive cancer and its complications.

Three years ago, Mrs. Davis had had a subtotal colectomy for adenocarcinoma of the colon. She was readmitted three months ago with metastasis to her liver and underwent further surgery. Postop complications of hemorrhaging, intraabdominal abscesses, and wound dehiscence required return trips to the OR. In spite of the repairs, the

wound wasn't healing and ascitic fluid drained through the suture line. The sutures were removed so that the open wound could drain and be cleaned. It measured 30 cm side to side, 12 cm at the center, and 10 cm at either end.

Comfort was a high priority

Mrs. Davis' condition became increasingly unstable—bilirubin and creatinine were rising daily, signaling progressive liver and kidney failure. After extensive discussion, she and her family decided against any more surgery or heroic measures, and a "no-code" order was written. We were to keep her as comfortable as possible.

With the sheet pulled away, Mrs. Davis shivered until we placed a flannel blanket across her chest. We all shared the same thoughts keep her comfortable . . . she needs to rest . . . she needs to be dry and warm . . . we need to find a better solution. We wanted more than anything to make her last days peaceful. Working with our enterostomal therapy nurse, and an OK from her doctor, we did find a way.

As soon as it was time for the next dressing change, we brought the supplies to the bedside and told Mrs. Davis what we planned to do. We'd use a transparent dressing to protect the wound and a soft, double-lumen catheter (a Lavacuator) to manage the drainage. We've repeated the procedure—outlined in the step-by-step instructions beginning on page 24—with continued good results and shared our successes with other units.

Benefits beyond our expectations

Our technique not only protected the wound, diverted the drainage, and allowed for healing; it made Mrs. Davis more comfortable: It eliminated the need for frequent dressing changes, kept her dry, and allowed her much needed rest.

We could turn and position Mrs. Davis without fear of dumping pockets of fluid drainage onto the dressing and linens or of disturbing the integrity of a new dressing.

Collecting the drainage from Mrs. Davis' wound gave us important

clinical information. The amount of drainage was staggering; up to 700 ml each shift. Samples were analyzed for electrolyte and amylase content. This data as well as the record of drainage output played a vital role in determining replacement fluids to manage her blood pressure and provide the correct total parenteral nutrition therapy.

Such determinations are especially important in critically ill, hemodynamically unstable patients. The big swings in volume that Mrs. Davis had experienced were controlled by stabilizing her fluid status, and her condition improved enough that we were able to taper her off vasoactive drugs.,

The transparent dressing permitted us to immediately, assess any changes in the drainage and to detect bleeding. Each shift recorded drainage volume, checked the dressing for leaks and the wound surface for changes, and made certain that both lumens of the catheter were patent. Routine irrigation through the irrigation/vent port on the Lavacuator with 30 ml of normal saline together with its vented design helped prevent clogging. If prescribed, wound irrigations with an antibiotic solution can be administered through the Lavacuator while maintaining a closed system.

If the dressing leaked, it was not necessary to remove the entire dressing. We simply cut away the Op-Site at the leak, cleaned and dried the skin, and reapplied Skintac-H. Then we cut a patch of Op-Site one inch larger than the opening we'd made and applied it.

Mrs. Davis' dressing remained intact for seven days. Although

the size of the wound remained the same, its appearance improved noticeably.

Savings in time and in money

We've continued to use this dressing technique with other patients with great success. Because frequent dressing changes are eliminated, healing granulation tissue and the white blood cells and antibodies on the wound's surface are undisturbed. The moist environment prevents dehydration. Epithelialization occurs more quickly than with standard dressings.

The costs and time invested are far less than with a traditional dressing. Depending on the needs of the patient and the integrity of the system, the dressing—as in Mrs. Davis' case—may be left in place for up to seven days.

As an added benefit, time we had spent redressing the wound was now precious time Mrs. Davis could share with her family.

An effective dressing for a large, draining abdominal wound

The wound care technique shown here uses the soft, pliable, double-lumen tube (at right) and a moisture vaporpermeable (MVP) dressing to contain and collect drainage, protect the wound, and encourage healing. Get the physician's OK for your plans, then gather the supplies that you'll need for both cleaning and dressing the wound. Lightly shave the skin around the wound, then wash the skin with a mild soap and water, rinse well, and dry thoroughly. Use acetone-alcohol swabs to defat the skin surrounding the wound to a two-inch border. Avoid the tender wound edge. Using aseptic technique, clean the wound itself with sterile normal saline.

Supplies

· Shave idt.

• Basin of warm tap water, mild scap, wash cloth, towel.

- Acetone-alcohol swabe.
- Starile normal saline.
- Storile gloves (two pair).
- · Sterile gauze pads.
- · Sciseors.


• Op-Site by Smith & Nophew (another transparent MVP dressing may be used, but it has to be one that adheres to itself—Tegaderm, for example).


• Skin-tao-H by Mason Laboratories or tincture of benzols.

• Stomaheelve paste by Convatec.



 Low section wall device with connecting tubing and tubing adaptor.






Apply a two- to three-inch border of Skin-tac-H, or other skin adhesive, to the skin surrounding the wound. After this becomes tacky, apply Stomahesive paste near the wound edge, circling the entire wound. This will serve as a seal to help prevent leakage and is helpful on irregular surfaces.




Lay the Lavacustor along the lower surface of the wound but a sufficient distance from the edge to assure that only drainage is suctioned. Have the catheter exit from the upper edge of the wound.



Measuring the wound side to side, cut the Op-Site into workable strips long enough to allow for a two-inch border on each side of surrounding sidn. Starting at the bottom of the wound, lay each strip down without tension. Overlap each previous strip by at least one inch.



When you reach the point where the Lavacuator exits the wound, lift it slightly, and pinch the Op-Site around it to form a seal.



Connect the suction port of the Lavacustor to the wall suction tubing with a catheter adaptor.

Dejoint and cut the tips off of chicken wings.⁺ Fry wings in a deep fryer (the oil temperature should be approximately 350 degrees)

Cook until crispy - approximately 12 to 15 minutes.

Remove from fryer and cost wings lightly with special "hot sauce" (see reverse)

Serve wings warm.

To prepare hot sauce: ingredients 1 cup Frank's Louisiana Hot Sauce 1/4-1/2 cup melted butter 1/4 tsp. chili powder 1/4 tsp. cayenne pepper 1/4 tsp. granulated garlic 1/4 tsp. granulated onion (optional) 1/4 tsp. salt 1/4 tsp. pepper 4-6 drops Tabasco sauce





-Manuscripts will be reviewed anonymously and by three committee members. Three manuscripts must be submitted.

-Manuscripts should be sent directly to the President, Karen Granby, RN, MS, CETN, 7475 Forest Brook Boulevard, Centerville, OH 45459.

-The award will be conferred at the Annual MidEast Regional Conference. -Submissions must be received by September 15th each year. Manuscripts received after that date will be considered for the subsequent award.





One of my primary goals during my term of office is to improve the communication systems of the IAET. I believe communication starts with



Results of 1988 MidEast Membership Questionnaire Questions 6-8 (Conclusion)

6. What would be the best way to enhance communication between already organized ET nurse groups?

Join State speciality nurse organizations.

Rotate meeting sites in each state.

Communication is OK, it's the competitiveness that keeps the ET nurses from supporting one another.

Encourage each group to do record keeping (minutes), and send the MidEast Region President a copy. This information would keep the President better informed and in a more timely fashion, then the President could directly communicate with a particular group if desired.

Regular scheduled meetings with an agenda.

Dropper should be shorter and come sooner--often old news.

Be sure to send report of meetings in the **Dropper.**

Educational devices could be offered to groups at reasonable prices.

Co-host educational seminars/programs.

"Special Edition" of newsletter or phone tree if issue is urgent. Section in **Dropper** to promote workshops in geographic areas.

Council type program.

Phone calls if an emergency or need to communicate fast.

Local groups could be listed in the **Dropper** according to their area, and the name of ET nurses responsible to contact in order to share happenings specific to own group.

Invite neighboring area ET nurses to join for meetings.

Meeting of representatives from each group with officers 1-2 times a year.

Make better use of **Dropper** as communicative tool.

It depends on the ET nurse group! Local ET nurses use flyers and postcards, National ET nurses use publications and brochures, Regional ET nurses use flyers and newsletters with occasional postcards.

Regional meetings--More of us could go if it were over a weekend. Difficult to get time off any more, too busy. Have one person from each group designated as a communication officer and send or call all communications to them.

Send copy of meeting minutes to the other groups.

Sharing program objectives and ideas.

Coordinating and standardizing teaching methods and ideas within local georgraphical areas.

Assign one person as a reporter.

ET nurses who practice in isolation should get themselves on mailing lists of some of the other groups and maintain phone contact too. Regional meetings are good places to network, also "reps" sometimes provide some of that information.

Possibly invite outside ET nurses to participate in programs.

Let groups know they can function as a committee--someone in the group has to accept leadership role in order to coordinate functions.

Regional President could ask a group to take over a project or committee.

7. What would be the best way to communicate these "ET Nurse Groups" to those who do not attend?

Periodically (twice a year) publish a list of the local ET nurse groups in the Dropper. Include meeting schedule and contact person.

Pre-Conference IAET Board "Highlights"

A Wish List has been compiled by IAET and Regions are being asked to consider supporting an item of their interest. The list is made up of proposed projects; for example, ongoing funds for Standards.

1990 Conference Site will be in Las Vegas. Location is next door to Caesars Palace at the MIRAGE. Rate will be \$68.00/night. June 12-15.

ET Nurse day is always the 3rd Wednesday of April. In 1990 it is planned for April 18th. In the future, only new members will receive a complete promitional packet regarding ET Nurse day. Other members are asked to save the information for future reference. A memo will be sent, however, to each member prior to the event.

After 1990, Certification is not going to be planned in conjunction with conference. 188 are taking the exam this time, of which 73 are being recertified. Future applicants must produce a copy of their graduation certificate from an approved school prior to taking the exam. Gold pins are now available to all board certified ET nurses. Cost is \$30.00

Concerns share regarding "Job security for ET Nurses"

1. Need research data to support cost effectiveness.

2. Need data shared regarding reasons to retain ET Nurses.

3. Need to know how to write proposals to our administrators and learn the language to convice of need for retention of ET nurses within the insitutions.

IAET name change proposed. Reasons submitted to justify changing:

1. Identity problems.

2. IAET doesn't state "nursing" as an important entity. General feeling was that the word "nursing" should be stated.

3. Suggested saying - E.T. Nursing Journal instead of Journal of Enterostomal Therapy.

4. **JET** publisher recommended selecting a general title to "cover" wound care and incontinence as well as stomal therapy.

5. Was proposed to state on front of **JET**, the statement of purpose of journal.

Alternative Pathways proposed for entry into ET Nursing training (See Alternative Pathway Recommendation)

1. Plan is to implement by January 1, 1990.

2. Currently there are 8 ETNEP programs.

ETNEP DIRECTORS RECOMMENDATION

FOR ALTERNATIVE ENTRY PATHWAY

The ETNEP Directors recommend the establishment of an alternative to the baccalaureate degree with a major in nursing requirement for admission into an ETNEP. The proposed alternative pathway is as follows:

Requirements:

1. RN

- 2. Baccalaureate Degree (or)
- 3. Demonstration of Baccalaureate nursing competencies to include: Health Assessment Community Health Nursing Leadership/Management Systematic Investigation

Baccalaureate nursing competencies may be demonstrated by either:

- 1. Satisfactory completion of course work for college credit, documented by transcript, or
- 2. Satisfactory completion of approved baccalaureateachievement tests (e.g., NLN Mobility Profile; ACT-PEP)
- 3. Masters in nursing without baccalaureate in nursing.

The process for admission approval is as follows:

- 1. Submission of portfolio demonstrating achievement of competencies.
- 2. Review by committee composed of two ETNEP directors and one member of the Accreditation Committee.

"Highlights of" Post Conference Board Meeting of IAET

 Proposed dates for 1990 conference -- June 11 - 15 will be held in Las Vegas at the "Mirage".

2. Alternative Entry Pathway was approved by the Board.

a. Data collected was analyzed by a task force.

b. Reasons considered:
*Nursing shortage.
*Concern for viability of organization.
*To allow rural nurses entry.

3. Association name change will be placed on agenda for Executive Work session.

4. Ethics Committee -recommended as a standing committee.

a. Proposed composition is 5 "full members".

d. Committee will be asked to consider an advisory panel consisting of:

> Clergy Attorney Ethicist

e. Committee wil be provided with House of Delegates recommendations, and will report back to Board at Semi-Annual meeting.

5. IOA Magazine -- IOA can no longer afford postage to send magazine and will stop automatic mailing at the end of 1989. IOA asked IAET to distribute the 20 magazine if it were provided &ree to the association. Approximate cost to distribute is \$800/issue two times per year. Due to budget constraints, IAET will not assume cost of taking over the mailing.

Report to MidEast Region

Consideration is being given to change the application and evaluation tool. My goal is to streamline the process and facilitate the awarding of funds to the recipient.

My committee assignment is indeed challenging and will provide me with a tremendous learning experience.

The IAET Board of Directors was asked to select goals for 1989-1990 in order to determine the direction the IAET will take for the next year. **Priority goals celected were:** * Promotion and justification of the speciality of ET Nursing.

* Educating ET Nurses to the full scope of practice with the initial emphasis on wound care.
