
News From Around the Region

Requirements for Elected Officers

To hold an office, a person must be an eligible member for at least one year immediately prior to election and have consented in writing to serve. No Regional officer may concurrently hold a national W.O.C.N. office.

Each officer shall be elected for a term of two (2) years, and no officer shall be elected to the same office for more than one (1) consecutive term.

Elected Trustees

No person shall be elected to the Board of Trustees who has not been an eligible member for at least one year immediately prior to election, and who has consented to serve in writing.

Each Trustee shall be elected for a term of two (2) years. No person shall be elected for more than one (1) consecutive term.

Treasurer Duties

- Have the care and custody of all funds of the region
- Sign all checks for the region
- Keep accurate books of account, and give a written financial report to Board of Trustees and Membership
- Become bonded
- Exercise all duties related to being treasurer

Trustee Duties

- Attend all board and membership meetings
- Oversee assigned committees
- Serve as advisor to President
- Write a report for each region newsletter

TALES FROM THAILAND... LIFE AFTER TSUNAMI

Barb Metz recently took a trip to Thailand, and visited villages where the December 26, 2004 Tsunami left a wake of devastation. "This was a phenomenal opportunity", Barb said, that came about as a result of the company her husband works for-they have an office in that region of the world. Barb was able to loan some nursing perspective on community projects, and was able to give some good ideas to the locals on basic issues.

Barb told a story about one of the office workers who was on vacation in the area during the literal time that the Tsunami hit. He remarked that he was with his two children, in a boat, and while he thought the water was "acting funny", they were not injured, not did they see anything. Upon return to their resort, the village was gone!

"People were so kind...we were walking on the beach one day, and a [Thai] lady was sitting on a matt. She was paralyzed in one arm, and we didn't know her. But she offered us a drink of water or a coke..." Barb said. It was amazing that even though these people had so little, they were very willing to give to her, a stranger.

Barb visited lots of people while in Thailand. One woman had lost her husband in the Tsunami—they owned a grocery store there. She and her two children have been able to re-open the gro-

cery store, as Barb's husband's company restocked the grocery shelves, and gave the woman inventory to restart the business, so that she could stay there and make a living.

Barb visited three different islands while on her trip. Each had varying degrees of damage. Barb relayed that it's so flat



there, that you can see the water. As a matter of fact, one resort owner actually said that he could see the Tsunami coming for about 15 minutes, before it hit—he just didn't know what it was. By the time the people knew it was a wall of water, they started to head for high land, but it was too late. The island Barb stayed on had some barrier islands, so it sustained little damage, but the degree of damage did seem to be impacted by how deep the shore of the particular island was.

Barb relayed that at first, the government allowed just a few houses to be rebuilt, but as time is going by, things are getting better. Also, there is a lot of edu-



cation of the people going on, to try to make them not be afraid of the water

Barb actually stayed in a Muslim fishing village on the mainland. It is from here that many truckloads of sand and rock that are divided into sacks, then loaded on boats, then sent to the islands. It is very hard and manual labor to achieve all these things for rebuilding.

One of Barb's interesting experiences, was that of seeing a new boat be placed in the water. She told the story of a Muslim Abbott (a Priest) blessed the boat. Barb said that in the boat, dishes of seafood, rice and other things are placed, Also, colorful ribbons are braided around the bow of the boat for good luck to the boat and to the fisherman. Then, the boat is taken to the water, placed in, fixed for leaks, and if all is well, goes into commission!

Barb also visited Bangkok, while in Thailand. She said there literally are elephants walking around in the streets, and it is a "very interesting" city.

Thanks, Barb, for sharing your story!

I. CALL TO ORDER/WELCOME: TERRI ROSS: Called the meeting to order at

11:50 a m

II. INTRODUCTIONS, RECOGNITION OF FIRST TIME ATTENDEES, WELCOME PAST PRESIDENTS: Terri Ross welcomed members to the regional meeting. Thirteen first time attendees were recognized and introduced. Allyn Davies, past president was recognized.

III. QUORUM DETERMINATION/VOTING GUIDELINES: GLENNA ALTIZER:

Quorum declared. The rules of meeting and voting guidelines were reviewed.

IV. ADDITIONS/DELETIONS TO AGENDA: Terri Ross added the following under new business: "B. Tax Exempt Status. C. Door Prizes. D. Nominations Committee Drawing. E. President's Award." Mary Merrill moved that the revised agenda be approved. Sue Schaeffer seconded the motion. Agenda approved.

V. SECRETARY'S REPORT: BECKY ROBERTS: June 5, 2004 membership meeting minutes were reviewed. Becky Roberts moved that minutes be accepted as written. Allyn Davies seconded the motion. Minutes approved.

VI. TREASURER'S REPORT: CECILIA KRUSLING:

The checkbook balance as of September 30, 2004 was \$25936.71. The money

market account balance was \$19924.20. The 2005 Budget was presented. The fee for bonding (due every 3 years) was included. The ET nurse of the year award was increased. The money market account included a \$125 management fee.

TRUSTEE #1: LISA KIRK:

1.WEB PAGE: Lisa Kirk reported that Sonya Perry has updated the

2. RESEARCH: MARY ARNOLD LONG:

Poster Presenter Award: Mary Long presented the poster presentation award criteria (see attached).

b. Mid-East Region Nurse Researcher Award: Mary Long announced the winner of the Nurse Researcher Award as Nancy McClees, MSN, RN, CCRP. Her research was titled: "A Pilot Study Examining the Use of a Glycerin Suppository By a Person With a Descending or Sigmoid Colostomy To Establish Continence Control." Denise Taylor accepted the award on her behalf.

GOVERNMENT AFFAIRS: GLENNA ALTIZER: Glenna reported that two persons were sent from the region to attend NIWI this year, and two more will attend in 2006. The Web site has been updated for the election. Special links to related election information sites were added. Information updates will be emailed to members who have submitted an email address to national.

Cecilia Krusling attended NIWI this year, and was asked to become

a member of the national committee titled "WOCN Public Policy" Cecilia reported that the meetings are by conference call. The committee is assigned to check the forums for issues of interest, such as the recent change in OASIS documentation. They are informed about the issues such as the "Compact Nurse" licensure and licensure for Advanced Practice Nurses. Another responsibility is determining who receives awards from national to attend NIWI.

- 4. MEMBERSHIP: LISA KIRK: Reported that she has mailed membership information to new graduates of the ETNEP programs.
- 5. UOA YOUTH RALLY COUNSELOR SCHOLARSHIP: ALLYN DAVIES: Stated the region supported two persons in 2003 to serve as counselors for the UOA Youth Rally. No one applied in 2004 for the scholarship.
- B. TRUSTEE #2 MARILYN WHITEHEAD: Terri Ross reported for Marilyn.

I. PUBLICATION: RITA POCHARD: Rita announced her plan to resign as editor of the Mid-Eas Dropper. She is willing to help the next editor. Administrative help is being sought to facilitate publication of the Dropper.

Rita proposed that the ad rates stay the same since the Dropper is going to two issues a year. The proposed deadlines were: Spring issue deadline of April 15 with Dropper to membership by May 15.

Getting To Know You

In this issue, let's Get To Know Sonya Perry, the MER webmaster (or is it webmistress....?)

Hello fellow Mid-East Region members. My name is Sonya Perry. I have been a member of the Mid-East Region WOCN since I began my ET career in 1998. I am certified in wounds, ostomies and continence. I've been asked to be "profiled" for our new edition of the MidEas Dropper. I was so honored that I felt I needed to participate. I graduated at 30 years of age from Marshall University in Huntington, WV with my BSN. I am very proud that I chose nursing as a career. Looking back now I still feel a sense of accomplishment about my graduation day and "passing the Boards". It was so great to have my family all together, especially my Grandparents. They were in their eighties then and still came to watch the ceremony. It was like the high school graduation I never had, since I quit school in the 10th grade. My husband Norman also received a diploma for his tolerance, and assistance at our family graduation dinner. He passed away in 1997 after a two year battle with cancer.

I am remarried now to Tim and we live on a 130 acre farm. Our combined family enjoys camping, hiking and boating. I like water skiing and knee boarding. Every year we look forward to a cabin at Babcock State Park when the autumn leaves are at their peak. No television, but plenty of time for family games, food and even pedicures. My daughter Bryana is 15 years old and son Timmy is 18. Timmy is graduating this year. They are both wonderful students and very responsible young adults. I also have twin grandsons by my older son Joshua. Gavin and Gage are 2 years old and are our little "munchkins". We enjoy when they come to visit on the weekends.

Even in nursing school I had always been interested wound care, healing, and prevention of pressure ulcers. My grandfather once said to me that "growing old is terrible". As a staff nurse I always admired the autonomy of our ET nurse, and wanted to find out more about how she became qualified to do her job. When I asked Connie Lawrence about her position, she was elated that I was interested. We talked and soon after that I was in Cleveland, Ohio taking classes.

I am employed at Charleston Area Medical Center in Charleston, WV. It's a three campus, level I trauma center. Memorial Hospital is one of the top 10 cardiac centers in the United States. It also has a Vascular Center of Excellence, several intensive care units, medical /surgical units and oncology. General Hospital is the Trauma Center which also has a renal, orthopedic and rehab unit. Women's & Children's Hospital has a medical/surgical gynecological unit, obstetrics, pediatrics and a very large neonatal ICU. Within these campuses we have a department of two Enterostomal Therapy Nurses. We may be consulted by physicians or nurses to see clients for wound, ostomy or continence needs. We may also be paged to see patients in outpatient surgery or medical clinics. The majority of our practice is pressure ulcers, vascular ulcers and ostomy education.

As a WOC nurse I am proud of the work our department has done to influence pressure ulcer prevention and treatment. As I read my Journal of WOCN and review abstracts and poster presentations online I realized more and more how far we have to go. I want to continue to grow within my practice and contribute to the healing of chronic wounds. One of my goals is to participate in case studies and outcome research studies with physicians. I would like to work with patients who have vascular and diabetic ulcers, and be more involved with some of our trauma wounds with the use of negative pressure wound therapy. Eventually I would like to publish some case studies or articles in our Journal of WOCN to contribute to the healing of patients with chronic or traumatic wounds.


