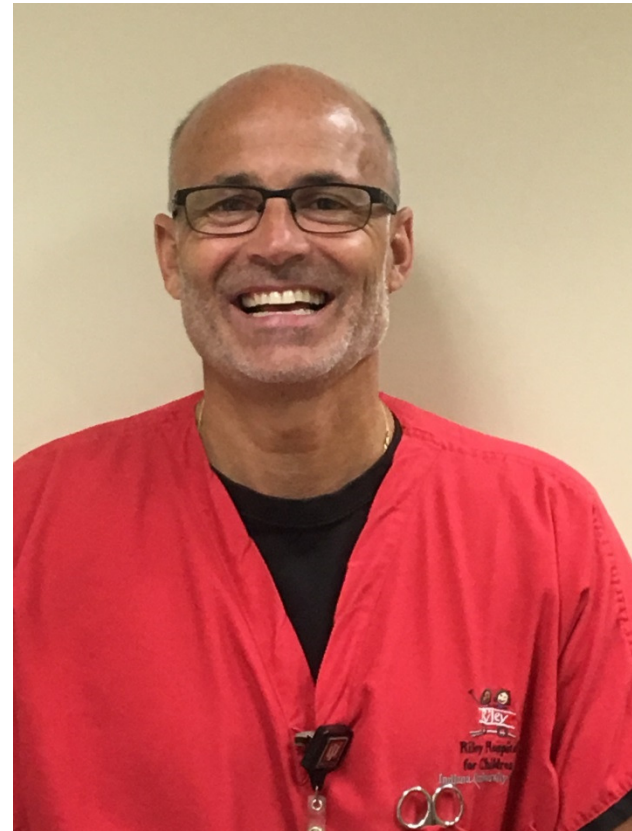


# Director 1 Nominee
